Well-versed in commercial litigation, Levi has handled matters ranging in complexity from pleading through trial with efficient and effective results. He routinely handles mediations, arbitrations and other forms of alternative dispute resolution.

Levi also has a thriving pro bono practice. Some of his cases include winning relief from deportation on behalf of a father and son fleeing gang violence and death threats in Central America, obtaining permanent residency on behalf of an immigrant under the Violence Against Women Act, and achieving a favorable settlement in a civil rights lawsuit brought by students in Mobile, Alabama.
