Prior to joining Katten, Rachel broadened her legal research skills as executive technical editor of *Harvard Journal of Law & Gender* and senior article editor of *Harvard Law & Policy Review*. Rachel honed her written and oral advocacy skills in Harvard Law's Ames Moot Court competition, in which her competition team advanced to quarterfinal oral arguments. During law school, she conducted research and interviews with Professor Susan Cole and other student advocates, centering on foster care issues in Massachusetts. This work shaped Rachel's focus on innovative legal solutions for clients and her attention to detail.
