

Supreme Court Poised to Limit Tort Claims for Historic Pollution

This article discusses an environmental case recently accepted for review by the US Supreme Court where the US Court of Appeals for the Fourth Circuit found the Comprehensive Environmental Response, Compensation and Liability Act preempts state statutes of repose as well as limitations.
