He has helped clients identify and purchase patent portfolios that later sold for a much higher price. He has found flaws in patents a client was looking to buy, helping the client to negotiate a much lower purchase price than originally contemplated. He has also helped clients find third-party funding to sue infringers or otherwise pursue a monetization campaign, addressing the company's concern that infringement litigation would not be cost-effective. In all these ways, Sean uses his knowledge of intellectual property to expand the legal and business possibilities open to his clients.
