

Katten IP Partners Receive Accolades in *World Trademark Review 1000*

World Trademark Review recognized Katten and four Intellectual Property attorneys in the 2022 edition of *WTR 1000 – The World's Leading Trademark Professionals*, which is a research directory that solely focuses on trademark practices and practitioners. *WTR 1000* identifies the leading trademark practitioners and firms in key jurisdictions across the globe.

WTR 1000 featured Katten on the national level and regionally in Washington D.C., and further recognized the Illinois and New York offices with distinctions. Katten Chairman Roger Furey, Karen Artz Ash and Floyd Mandell, partners and co-chairs of the firm's Trademark/Copyright/Advertising/Privacy practice group, and partner Kristin Achterhof also received individual distinctions and accolades in the areas of "prosecution and strategy" and "enforcement and litigation." Members of this group have consistently been recognized by *World Trademark Review* for more than a decade.

Noting that Katten leads the shortlist of law firms for many major names in the fashion world, *WTR 1000* highlighted Karen's stature as a "doyenne of the industry" and the widespread respect she has garnered through her counsel and strategic insight.
