



## Katten Represents Buyer Group in Majority Stake Purchase of Charlotte Hornets

A Katten team represented a group purchasing a majority stake in the Charlotte Hornets, ending basketball superstar Michael Jordan's 13-year majority ownership of the National Basketball Association team. He is maintaining a minority interest in the team.

The buyer group was led by Gabe Plotkin, a hedge fund founder and manager, and Rick Schnall, a private equity firm president and includes rapper J. Cole and country music artist Eric Church as well as former minority stake owner Dan Sundheim, Chris Shumway, Ian Loring, Dyal HomeCourt Partners, Andrew Schwartzberg and local investors Amy Dawson and Damian Mills.

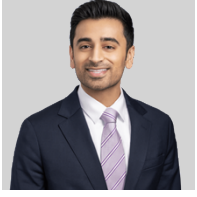
