



Media Abuzz Over New Katten Chair-Elect Gil Soffer

Several news organizations — including *Bloomberg Law*, *Reuters*, *Law.com* and *Law360* — have featured articles covering [the news that Gil Soffer has been tapped to become Katten's next chairman](#) in July. Gil, a former federal prosecutor and currently head of Katten's Chicago office and co-chair of the firm's Litigation Department, will succeed Roger Furey, a Washington-based Intellectual Property partner and former chair of the firm's DC office who has been chair since 2016.

"I have spent the bulk of my career here, and I am deeply grateful for the outstanding contributions of my colleagues, attorneys and business professionals, who make this a firm we can all be proud of," he said. "As we near our 50th year as a firm — clearly one that has thrived despite the challenges facing our industry — I look forward to continuing to deliver the highest levels of client service and building on the successes we have achieved under Roger and [CEO Noah Heller's] leadership."
