



## Katten Represents Highlander Partners in Benestar Brands Merger With Palmex

A Katten team led by Corporate partners Mark Solomon, Peter Bogdanow and Christopher Isaacs represented Highlander Partners (Highlander), a Dallas-based private investment firm, in the recent merger of its Chicago-based portfolio company Benestar Brands (Benestar) with Palmex S. de R.L. de C.V. (Palmex), a portfolio company of Wind Point Partners.

As spotlighted by *PR Newswire*, the merger creates a "powerhouse" entity in the North American snack industry. We're thrilled about the endless possibilities this partnership opens up, including leveraging each company's unique capabilities to drive growth and market penetration."

By combining Benestar's renowned brand portfolio with Palmex's state-of-the-art pellet extrusion capabilities, we're setting the stage for a new chapter of innovation and accelerated growth at the company."
