NYDFS Cybersecurity Regulation Compliance Requirements for November 1, 2024

As we previously <u>reported</u>, in 2023 the New York State Department of Financial Services (NYDFS) <u>amended</u> its cybersecurity regulation, 23 NYCRR 500 (or Part 500). NYDFS has now published guidance on the implementation timeline for key compliance dates for the various categories of entities impacted such as <u>Small Businesses</u>, <u>Class A Companies</u> and <u>Covered Entities</u>. Numerous requirements will become

The European Commission Reports on the First Year of the EU-US Data Privacy Framework

In July 2023, the European Commission adopted an adequacy decision for the EU-US Data Privacy Framework (DPF), as Katten has previously reported. This permitted the free flow of personal data from the EU to DPF-participating companies in the United States. On October 9, 2024, the European Commission issued a review of the adequacy decision of the EU-US DPF to the European Parliament and Council of Europe after its first year in force.
