In addition, Terry has made oral arguments to the Supreme Court of Virginia, the US Court of Appeals for the Federal Circuit, the US Court of Appeals for the District of Columbia Circuit, the US Court of Appeals for the Second Circuit, the US Court of Appeals for the Fourth Circuit, and the US Court of Appeals for the Ninth Circuit.

In addition to representing clients in litigation, Terry is active in representing clients in non-litigation settings. Terry regularly represents content providers in licensing content, as well as in the review/clearance of content. He is frequently retained in connection with "brand protection." This work includes combatting counterfeiting, cross-border enforcement, domain name disputes, policing brand misuse on social media and in e-commerce, and performing clearance searches.

During law school, Terry was a member of the managing board of the *Virginia Law Review*. Upon graduation, he clerked for Judge Roger Robb on the US Court of Appeals for the District of Columbia Circuit.
