## Katten Hosts 2014 Women's Energy Summit Bringing Together Top Women Business Leaders to Discuss Critical Water and Energy Issues

The day-long Summit, led by the Illinois Commerce Commission, was attended by regulators, industry leaders, government officials and community representatives, and was held at The Metropolitan Club, located on the 66th floor of the Willis Tower.

"This is an important opportunity for some of the female power players in the industry to come together and discuss crucial issues involving not only critical diversity issues but also substantive issues regarding the future of the utility industry and the intersection of energy and environmental regulations, as well as potential solutions," said Shannon Broome, partner and head of Katten's Air Quality and Climate Change practice, who was a Summit panelist.
