# **COVID-19 Emergency Orders Affecting Real Estate** Virginia

#### MORTGAGE ENFORCEMENT LIMITATIONS

#### April 22, 2020 - Statewide Legislation

House Bill 340 was enacted providing (a) a 60-day stay of an unlawful detainer for nonpayment of rent for residential tenants, and (b) a 30-day stay of foreclosure proceedings for homeowners of, and owners who rent to a tenant, a one-family to four-family residential dwelling unit, who request a stay and provide written proof, defined in the bill, that they are (i) an employee of the United States government, (ii) an independent contractor for the United States government, or (iii) an employee of a company under contract with the United States government who was furloughed or was or is otherwise not receiving wages or payments as a result of a closure of the United States government, defined in the bill. In addition, the bill was modified at the Governor's request to expand the available relief described above to any tenant, homeowner, or owner affected by the novel coronavirus (COVID-19) pandemic public health crisis during the period for which the Governor has declared a state of emergency. This appears to include commercial tenants, but it is not entirely clear.

#### March 16, 2020 (and amended April 22, 2020 and May 12, 2020) - Supreme Court of Virginia

### LANDLORD/TENANT ENFORCEMENT LIMITATIONS

#### May 21, 2020 - City of Alexandria

The City of Alexandria has announced the COVID-19 Emergency Rent Relief Assistance Program to provide funds in the amount of \$600 per month for up to three months directly to property owners on behalf of eligible tenants. Eligible tenants live in the City of Alexandria, document loss of income directly related to COVID-19, are current on rent as of March 31, 2020 and fall below certain household income and asset thresholds. <a href="https://www.alexandriava.gov/housing/info/default.aspx?id=115425">https://www.alexandriava.gov/housing/info/default.aspx?id=115425</a>

#### April 22, 2020 - Statewide Legislation

April 2, 2020 - City of Alexandria

The City of Alexandria has asked Alexandria landlords not to pursue evictions for late April rent payments; to work
with tenants on payment plans to repay late rent over the next 12 months; and to waive late fees and other penalties.
The Office of Housing's Landlord-Tenant Division is available to help landlords and tenants draft and implement
installment plans.

#### March 24, 2020 - Office of the Arlington County Board

 The Arlington County Board requests that Arlington County property owners and managers work proactively with tenants that are experiencing significant or full business disruption to provide rent relief and other tangible measures that allow these tenants to remain in their space when business operations fully resume. The Board further requests property owners and managers not file eviction proceedings against any tenant who is in arrears on rent for at least the next three months.

notarization is currently authorized (listed in a table in the letter), subject to terms and conditions listed in the letter.
