# NON-ESSENTIAL BUSINESS RESTRICTIONS / STAY-AT-HOME ORDERS

#### **State of Emergency:**

The Governor of Maryland has issued a Declaration of a State of Emergency and Existence of Catastrophic Health Emergency effective as of March 5, 2020. This Declaration was last renewed on July 1, 2020 and remains in effect until further notice.

#### **State of Maryland Orders**

#### **August 3, 2020**

 The July 29 order is amended and restated to clarify that political subdivisions may not issue more restrictive orders requiring schools to close or modify their operations.

#### July 29, 2020

• The June 10 order is amended and restated to allow for the reopening of religious facilities, retail businesses, organizations, establishments and facilities in the State of Maryland to reopen subject to a 50% maximum occupancy cap and any applicable Local Orders and Secretary's directives. Salons, barber shops, tattoo parlors, tannings salons, massage parlors and nail salons may remain open provided services are provided by appointment only, the establishment does not exceed 50% maximum occupancy, and the establishment must disinfect the service area after each customer. The order also provides certain restrictions applicable to indoor and outdoor recreation establishments; foodservice establishments, fitness centers, casinos and racetracks, and other businesses.

#### June 10, 2020

 The June 3 order is amended and restated to allow the reopening of additional businesses and facilities, subject to local regulation and any directives that may be issued by the Secretary of Health.

of the state of emergency and proclamation of the catastrophic health emergency has been
rescinded, or until rescinded, amended, superseded or revised by additional orders.

• The Court of Appeals of Maryland has established a phased reopening of the state court system. Under Phase I, in effect through June 5, 2020, the courts are only hearing certain emergency and urgent matters. Under Phase II, in effect from 5:00 pm on June 5, 2020 through July 19, 2020, the Court of Appeals and Court of Special Appeals will be fully operational and the District Courts may hear landlord and tenant disputes relating to emergency breach of lease involving threats or injury to people or property and emergency wrongful detainer actions. Under Phase III, in effect from July 20, 2020 through August 30, 2020, District Courts may hear landlord and tenant disputes relating to rent escrow actions, tenant holding over actions, and warrants of restitution. Under Phase IV, in effect from August 31, 2020 through October 4, 2020, District Courts may hear landlord and tenant disputes related to failure to pay rent cases. Under Phase V, in effect from October 5, 2020 forward, all courts are fully operational.

# April 10, 2020 - Order of the Governor of the State of Maryland

 Wills, powers of attorney, and advance directives can be signed electronically and witnessed remotely by video conference.

# March 31, 2020 - Fannie Mae Lender Letter (LL-2020-03)

 Fannie Mae allows Lenders to sell loans with remotely notarized loan documents from states where remote notarization is currently authorized (listed in a table in the letter), subject to terms and conditions listed in the letter.

#### March 31, 2020 – Freddie Mac Selling Guidance Related to COVID-19

Freddie Mac allows Sellers to sell Mortgages to Freddie Mac where remote notarization
was properly used in a state that currently allows remote notarization (listed in an
attachment to the guidance). Freddie Mac provided specific requirements for qualifying
Remote Online Notarization.

# March 30, 2020 - Order of the Governor of the State of Maryland

- The in-person requirement for notarizing documents is temporarily waived until the termination of the state of emergency. Remote notarization using a communication technology with both audio and video is permitted.
