 Governor Ron DeSantis issued Executive Order Number 20-223 permitting Miami-Dade and Broward counties to move into "Phase Two" of re-opening as detailed in Executive Order Number 20-139 (issued June 3, 2020; see summary below).

June 3, 2020 - Office of the Governor Executive Order Number 20-139:

• Governor Ron DeSantis issued Executive Order Number 20-139 permitting Florida (other than Miami-Dade, Broward and Palm Beach counties) to enter "Phase Two" of re-opening the state economy by, among other things, allowing, subject to appropriate social distancing and sanitation protocols, (1) retail establishments, gyms and fitness centers to operate at full capacity, (2) restaurants to permit bar-top seating, (3) bars to open and sell alcoholic beverages at 50% of capacity inside and full capacity outside so long as they operate under a strictly "seated" service, (4) entertainment businesses such as movie theaters and concert venues to operate at 50% of capacity and (5) personal services (including, without limitation, tattooing, body piercing, acupuncture, tanning and massages) to operate with appropriate safety guidelines as outlined by the Florida Department of Health. Nightclubs are still not permitted to re-open at this time. Phase Two re-opening will only apply to Miami-Dade, Broward and Palm Beach counties after each county seeks approval from the State with a written request from the mayor or administrator, as applicable.

• Governor Ron DeSantis issued Executive Order Number 20-123 permitting Florida to enter a "Full Phase One" of re-opening the state economy by, among other things, allowing (1) restaurants, retail establishments, museums, and fitness centers to operate in their indoor spaces at 50% of building capacity so long as the appropriate social distancing guidelines are in place, (2) the operation of professional sports, (3) venues to host training, competitions, events and games, (4) amusement parks to submit re-opening plans to the State of Florida that includes, without limitation, a proposed date for resumption of operations and proposed guidelines to ensure guest and staff safety. In addition, Counties in the State of Florida may seek approval from the State to allow operation of vacation rentals.

no more than 25% of building occupancy at all times and following social distancing guidelines). Bars, gyms, salons, and movie theaters are to remain closed during Phase One and the congregation of groups of 10 or more persons is prohibited at all times. Miami-Dade, Broward, and Palm Beach counties are currently excluded from Phase One. The re-opening of such counties will be further considered in consultation with local leadership.

 Governor Ron DeSantis issued Executive Order Number 20-87 ordering the suspension of all vacation rental operations (meaning the rental of condominiums, cooperative, or dwelling unit that is also a transient public lodging establishment for 30 days or less) for 14 days. Hotels, inns, resorts, and non-transient public lodging establishments are exempt from this order.

Governor Ron DeSantis issued Executive Order Number 20-68 that, among other things, requires (1) all bars and nightclubs throughout Florida to close for 30 days from the date of the order, (2) parties accessing public beaches in the State of Florida to limit their gatherings to no more than 10 persons and (3) restaurants to limit customer entry to 50% of its capacity and to provide staggered and limited seating to ensure parties are separated by a distance of at least 6 feet.

August 28, 2020 - Miami-Dade County Amendment to Emergency Order 28-20:

• Effective as of August 31, 2020, Emergency Order 23-20 (which was issued on May 15, 2020; see note on Executive Order 23-20 below) and Executive Order 26-20 (which was issued on July 2, 2020; see note on Executive Order 26-20 below), and replaces those orders with Emergency Order 28-20, which, among other things, (a) allows indoor dining restaurants to operate at 50% capacity, with six people maximum at a table, so long as social distancing and facial covering requirements are satisfied, and, while people are in establishments, HVAC systems are run with the fans "on" and doors and windows are kept open to maximize the circulation of fresh air and (b) provides Casinos may remain open following rules put in place, provided that food and beverages may only be consumed in designated areas and are prohibited at the gaming tables or slot machines.

July 7, 2020 - Miami-Dade County Amendment No. 2 to Emergency Order 26-20:

• Effective as of July 9, 2020, Emergency Order 26-20 (issued July 2, 2020; see summary below) is amended to, among other things, (a) close banquet halls, both stand alone and incident to any hotel or other establishment, and ballrooms, both stand alone and incident to any hotel or other establishment; (b) require masks or facial coverings to be worn when inside gyms and fitness centers; (c) limit restaurants and cafeterias to outdoor service only for on-site consumption between the hours of 6:00 a.m. and 10:00 p.m. each day, and require that such outdoor on-premises service cease at 10:00 p.m., but to provide that such establishments may operate their kitchens between the hours of 10:00 p.m. each night and 6:00 a.m. the next morning only for the purpose of providing delivery, pick-up, room service, or take out services; and (d) to further impose a maximum daytime and overnight occupancy for short-term vacation rentals of up to a maximum of two persons per bedroom plus two additional persons per property not to exceed a maximum of ten persons, and to prohibit new rental agreements entered into except on a monthly basis.

 Commencing as of July 4, 2020, Miami-Dade County amends Emergency Order 26-20 (issued July 2, 2020; see summary below) to close outdoor amusement facilities, adult theaters, special cabarets, and unlicensed massage establishments.

• Effective as of July 3, 2020, Emergency Order 25-20 is replaced and restated in whole to require, among other things, that hotels, motels and commercial lodging establishments from July 3, 2020 until July 6, 2020 to (a) close pools between the hours of 8 p.m. each night and 6 a.m. the next morning; (b) limit the use of pools to guests staying in rooms at the establishment, and overall capacity to 50 percent of the pool deck capacity; (c) not permit alcohol consumption or sales on pool decks prior to 11 a.m.; (d) only permit guests staying at the establishment to access rooms, and to strictly observe room occupancy limits; and (e) to state that hotels, motels, and commercial lodging establishments which violate those requirements shall close their pool and pool deck until 12:01 a.m., July 7, 2020.

• Effective as of July 1, 2020, Emergency Order 23-20 (which was issued on May 15, 2020; see note on Executive Order 23-20 below) is amended to provide, among other things, that restaurants and other food service establishments with seating for more than eight people shall close for on-premises dining between 12:01 a.m. and 6 a.m. each day. Notwithstanding the foregoing, such establishments may operate their kitchens for the purpose of providing delivery services, pick-up or take out services. Employees, janitorial personnel, contractors, and delivery personnel shall be allowed access to such establishments at all times.

Effective as of June 29, 2020, Emergency Order 23-20 (which was issued on May 15, 2020; see note on Executive Order 23-20 below) is amended to, among other things, (a) make changes to the attestation process for establishments that are in violation of such Emergency Order, (b) prohibit any establishment permitted to open and that serves alcohol from selling alcohol for on-site consumption between the hours of 12:01 a.m. and 6 a.m. each day and (c) affirming that hookah lounges must remain closed.

Additionally, no parades shall be allowed during this time period. Municipal firework shows may take place during this time period but only in strict compliance with the social distancing and facial covering requirements of prior Emergency Orders and all parks must close by 8 p.m.

• Effective as of June 20, 2020, Emergency Order 23-20 (which was issued on May 15, 2020; see note on Executive Order 23-20 below) is amended to state that an establishment that falls out of compliance with the Emergency Order shall immediately close, and that such business may reopen only upon (1) taking 24 hours to review this order and taking all necessary measures to come into compliance with its requirements; and (2) executing an attestation demonstrating that the review has been completed and the measures have been taken, and submitting the executed affidavit by email to IMT@mdpd.com or by mail to the Special Patrol Bureau/Incident Management Team.

• Effective as of June 8, 2020, Dade County will allow banquet halls, gyms, fitness centers, summer camps, youth activities, massage studios or parlors, and tattoo parlors to re-open if operated in accordance with the "Moving to A New Normal Handbook" and Emergency Order 23-20 (which was issued on May 15, 2020; see note on Executive Order 23-20 below); and provides a process for the opening of movie theaters, bowling alleys, amusement facilities, casinos, and other high risk but individually unique entertainment establishments.
